Can I mail a lithium battery?

In the next section, we'll go over USPS limitations and requirements for mailing these batteries. The Postal Service allows limited quantities of lithium batteries to be mailed domestically (within the U.S.) as long as certain conditions are met. Here are the key rules and restrictions to be aware of:

Can I ship lithium batteries via USPS?

#1: Yes, you can ship lithium batteries via USPS. However ... There are currently six types of lithium batteries eligible for shipment, in varying domestic or international quantities, via USPS: Don't forget the new lithium battery marks that became mandatory this year!

Can I ship lithium batteries overseas?

For shipping lithium batteries with USPS overseas, you can ship a maximum of 4 cells or 2 batteries that are installed in the new or certified refurbished equipment or device it operates, without any lithium battery markings. However, individual batteries are prohibited from USPS international shipping.

How do I ship a lithium battery?

USPS has official instructions and guidelines for shipping batteries. ShipSaving helps you to highlight the following information: All packages containing lithium metal or lithium-ion batteries that can be mailed must be of sufficient size, sealed, and rigid. This ensures that the lithium battery mark can be affixed to the address without folding.

Can a lithium battery be attached to a mailpiece?

Except for mailpieces containing button cell batteries properly installed in the equipment they are intended to operate, mailpieces containing mailable lithium metal or lithium-ion batteries must be rigid, sealed, and of adequate size, so the lithium battery mark can be affixed to the address side without the mark being folded.

Can a battery be mailed?

Multiple cell batteries inside the housing or casing exceeding 100Wh for each battery are nonmailable. Damaged/recalled individual batteries are prohibited and need approval. Domestic shipping via air: Maximum 8 cells or 2 batteries with or installed in the new or Manufacturer Certified Refurbished (MCR) equipment in the same package.

1. Is the lithium battery rechargeable? a. If the answer is yes, it is a lithium-ion (polymer) battery and you must: (1) Refer to UN3480 for lithium-ion batteries packaged without equipment. (2) Refer to UN3481 for lithium-ion batteries packaged with or in equipment. b. If the answer is no, it is a lithium metal (alloy) battery and you must:

You can find the lithium battery marking and labeling guidelines inside Section 7 of the latest copy of the Dangerous Goods Regulations (DGR) or the Lithium Battery Shipping Regulations (LBSR). What do the Lithium Battery Marks and Labels Look Like? The lithium battery mark is required as specified in the DGR. The border of the mark must have ...

What types of lithium batteries can be sent? Regardless of what domestic or international mail service you use, Australia Post can only carry the following types of lithium batteries: Lithium ion (rechargeable) - 20 watt-hour per cell or 100 watt-hour per battery; Lithium metal (non-rechargeable) - one gram per cell or two grams per battery

USPS Packaging Instruction 9E Lithium Metal and Lithium-ion Cells and Batteries -- International and APO/FPO/DPO. Lithium metal (non-rechargeable) cells and batteries and lithium-ion (rechargeable) cells and batteries are mailable in limited quantities internationally or to and from APO, FPO, or DPO locations only when they are properly installed in the equipment they operate.

Note. Effective July 1, 2015, all existing customers and new customers who wish to ship lithium metal batteries without equipment (UN3090) via UPS; Air services must obtain pre-approval from UPS Airlines. This requirement is to ensure that proper training has occurred and that all applicable safety regulations are properly followed for such shipments.

all types of lithium batteries are classified as dangerous goods -- with special regulations for packing, labelling, documentation and handling.

When shipping with USPS, these items can only be sent via Ground Advantage. USPS is enforcing restrictions for used electronic devices containing lithium-ion batteries. You can't drop these items in a mail collection box; you need to take ...

First and foremost, it's important to know which kind of lithium battery you are dealing with. The two main types of lithium batteries are lithium ion and lithium metal. They both contain high levels of energy. However, the main difference between the two is that lithium-ion batteries are rechargeable, while lithium-metal batteries are not.

Use a Lithium Battery Mark on batteries with less than 100 Wh or 2 g of lithium. Look online for a Lithium Battery Mark editor so you can add the information for your shipment. When you ship lithium ion batteries, use "UN3480" for single battery shipments and "UN3481" if they're packaged with equipment. For lithium metal batteries ...

When shipping almost any battery, you must protect all terminals against short circuits that can result in fires. Protect terminals by completely covering them with an insulating, non-conductive material (e.g., using electrical tape or enclosing each battery separately in a plastic bag), or packing each battery in fully enclosed inner packaging to

Electronic devices containing lithium batteries

You mail all items at your own risk. Among other exceptions and limitations that may apply, we make no coverage for damages available for shipments containing electronic goods that you ship in any packaging other than: ... If the electronic goods have lithium batteries, they must meet our requirements for domestic ground/surface mailing of ...

USPS Standards for Domestic Shipments Containing Lithium Batteries. Each cell cannot contain more than 1 gram of lithium; Each battery cannot contain more than 2 grams of lithium; All packages must contain a complete return address; For non-installed batteries, your package must have a DOT-approved lithium battery mark (UN3090)

A table in the Lithium Battery Shipping Regulations manual gives the precise weight of batteries per package on both cargo and passenger aircraft. All marks and labels must be clearly visible on the exterior of all packages and overpacks. Proper marking and labeling is required when shipping lithium batteries by air.

the Lithium Battery Safety Document and Battery Label, as described in this brochure. Place the completed Lithium Battery Safety Document in document pouch or resealable envelope and attach it to the outside of the package. Attach the completed Lithium ...

Quantity limits: Packages cannot contain more than 4 lithium metal cells or 2 lithium metal batteries, and cells can't exceed 1 gram of lithium content while batteries can't exceed 2 grams. For lithium-ion, packages are limited to 4 cells or 2 batteries with a maximum of 20 Wh per cell and 100 Wh per battery.

Lithium batteries are dangerous goods, and all of the regulatory requirements must be complied with, as set out in the Lithium Battery Shipping Regulations. In the United States, failure to comply with these regulations can result in a civil penalty of up to \$27,000 per offence (LBSR 1.3).

That's the only way you'll be able to send lithium-ion batteries packed outside of any equipment with any of the UPS air services. Pay Attention to the Rules of Your Shipping Software for Sending Lithium Ion Batteries with UPS. Some shipping software platforms have different rules when it comes to allowing lithium-ion battery shipments with ...

The U.S. Postal Service has announced new final rules, effective immediately, that significantly impact the shipping of lithium batteries and other hazardous materials by mail.. USPS cites "a consistent and alarming rise in incidents involving mailed packages of both lithium batteries and other hazmat, including ... unlabeled or improperly labeled air-ineligible hazmat ...

All "smaller" lithium cells or batteries packed alone or with - but not in - the equipment they are meant to power require the display of the lithium battery mark. The lithium battery mark is never required for "smaller" button cells or batteries contained in equipment (your situation). For other "smaller" lithium cells or ...

Yes, you can send a lithium battery or item containing a lithium battery by mail within Australia provided that you make sure that the item is safe to send. Lithium batteries and items containing lithium batteries are dangerous goods and can not be carried by Australia Post by air. Such items will be carried in the mail by road transport only ...

DMM Revision: Mailings of Lithium Batteries . Effective May 16, 2012, the Postal Service(TM) will revise Mailing Standards of the United States Postal Service, Domestic Mail Manual (DMM ®) section 601.10.20 to codify that primary lithium metal or lithium alloy (nonrechargeable) cells and batteries or secondary lithium-ion cells and bat­teries (rechargeable) are prohibited when ...

When using an air transportation service like Priority Mail, you'll need the UN3481 Lithium Battery Handling Label.
