The single biggest solar incentive in Florida is actually a federal tax credit. Residential Clean Energy Credit. The Residential Clean Energy Credit, formerly known as the federal investment tax credit (ITC), can reduce your solar panel system's cost by 30%. Your entire system, including all the equipment, labor, permitting, and sales tax, qualifies for the ITC.

In addition to a 100% property tax exemption for residential solar panels, Florida law also exempts solar from its sales and use tax. According to the Florida Department of Revenue, the exemption applies to equipment and any component currently certified by Florida Solar Energy Center as a qualifying solar energy component. This may include:

The federal solar investment tax credit will have the biggest impact on the cost you will face to go solar in Florida. If you install your photovoltaic system before the end of 2032, the federal tax credit is 30% of the cost of your solar panel system. This is 30% off the entire cost of the system including equipment, labor, and permitting.

The average homeowner in Florida will save \$40,676 in energy bills alone over the lifespan of their solar panels. If you're serviced by Florida Power & Light or Duke Energy -- which have the best net metering programs in the state -- you could even get paid by your electricity provider rather than the other way around, providing even more ...

You don't pay for the solar power equipment, but you definitely pay for the power it produces. With solar leases and PPAs, you do not own the solar panels, you simply pay each month to use the electricity they generate, and that fee is usually lower than what you would pay to your local utility company on your utility bills.
