To view listed equipment or download a copy of the active PV Module,Inverter,Energy Storage System (ESS),Battery,Meter,or Power Control System (PCS) lists please visit the Energy Commission's Solar Equipment Lists application.

When will my inverter/PCE application be assessed?

Applications will not be assessed until the Clean Energy Council has received payment of this fee. To have your inverter or PCE included on the Clean Energy Council approved products list,ensure that your products meet the requirements outlined above,then begin your application.

Where can I find a list of eligible inverters?

A complete list of eligible inverters can be found on the California Energy Commission (CEC) website. The list -- which is updated monthly -- contains over 3,200 eligible inverters. One of the main changes under UL 1741-SA is that inverters are now allowed to operate under a wider range of voltage and frequency levels.

Which inverters are eligible for use under Rule 21?

Inverters that are eligible for use under Rule 21 are those that have been tested and certified under the new UL testing protocol known as UL 1741 Supplement A(SA). A complete list of eligible inverters can be found on the California Energy Commission (CEC) website. The list -- which is updated monthly -- contains over 3,200 eligible inverters.

What is the grid support inverter list?
