Australia will launch its first tenders for large-scale energy storage resources during this year, in a scheme which will roll out across the country, "jurisdiction by jurisdiction".

Comparing tenders activity in energy storage segment in different regions of the globe, North America held the top position with ten tenders and a share of 45.5% during June 2021, followed by Asia-Pacific with six tenders and a 27.3% share and Middle East and Africa with four tenders and an 18.2% share.

In what is thought to be India's largest tender to date for standalone BESS resources, the state-owned corporation is proposing to sign Battery Energy Storage Purchase Agreement ...

On 21 August 2024, the Bulgarian Ministry of Energy opened a tender procedure for National infrastructure for storage of renewable energy (RESTORE) for granting stand-alone battery energy storage system (BESS) tender funded under the EU's Recovery Resilience Facility (the "Procedure"). The deadline for submitting applications will be 17:00 on 21 November 2024.

In 2020, pumped storage accounted for 90.6% of China's energy storage power capacity, taking the absolute lead. However, pumped storage, an energy storage technology with water as the medium, is limited by water resources and mature technology; thus, it has limited cost reduction space and a relatively slow cumulative power capacity ...

A total of 4,000MWh of pilot tenders for standalone energy storage are expected to be launched in total by the government of India. This is in addition to activities at state level, such as the current 500MW tender for renewables with storage being run by the electricity board in the state of Gujarat, to give one example.

The Bulgarian Ministry of Energy has invited public comment on a new initiative to offer tenders for 3GWh of energy storage capacity to help integrate renewable energy. In its current form, the tender consists of BGN1.2 billion (US\$660 million) in grant funding. Projects cannot apply for funding to cover more than half of their costs, and ...
