Unless Congress renews the ITC, this tax credit expires at the beginning of 2024. Colorado Solar Sales Tax Exemption. Colorado is focusing on powering the entire state with renewable energy by 2050. The Colorado Solar Sales Tax Exemption means that you don"t have to contribute to any state sales tax when you purchase a solar panel system.

Installing a solar system boosts your property value. According to the National Renewable Energy Laboratory (NREL), your home value increases by \$20 for each \$1 saved on annual electricity bills. For example, a solar energy system that saves you \$400 annually will add \$8,000 to your home"s value.

The Colorado site also collects information on electric vehicle incentives, and Polis noted that by stacking up all the federal and Colorado credits and rebates, some Coloradans could save as much as \$21,000 on a single qualifying electric vehicle.

Colorado enacted S.B. 07-145 in April 2007, authorizing counties and municipalities to offer property or sales tax rebates or credits to residential and commercial property owners who install renewable energy systems on their property.
