How much does battery storage cost?

The costs of installing and operating large-scale battery storage systems in the United States have declined in recent years. Average battery energy storage capital costs in 2019 were \$589 per kilowatthour(kWh), and battery storage costs fell by 72% between 2015 and 2019, a 27% per year rate of decline.

How much energy does a battery storage system use?

The average for the long-duration battery storage systems was 21.2 MWh, between three and five times more than the average energy capacity of short- and medium-duration battery storage systems. What is the future of battery energy storage systems?

The battery energy storage systems industry has witnessed a higher inflow of investments in the last few years and is expected to continue this trend in the future. According to the International Energy Agency (IEA), investments in energy storage exceeded USD 20 billion in 2022.

How much does an energy storage system cost?

Energy storage system costs stay above \$300/kWhfor a turnkey four-hour duration system. In 2022,rising raw material and component prices led to the first increase in energy storage system costs since BNEF started its ESS cost survey in 2017. Costs are expected to remain high in 2023 before dropping in 2024.

What is the average power capacity of a battery storage system?

For costs reported between 2013 and 2019, short-duration battery storage systems had an average power capacity of 12.4 MW, medium-duration systems had 6.4 MW, and long-duration battery storage systems had 4.7 MW. The average energy capacity for the short- and medium-duration battery storage systems were 4.7 MWh and 6.6 MWh, respectively.

Do energy storage systems generate revenue?

Energy storage systems can generate revenue, or system value, through both discharging and charging of electricity; however, at this time our data do not distinguish between battery charging that generates system value or revenue and energy consumption that is simply part of the cost of operating the battery.
