Will a tax credit be available for energy storage projects?

However, with the passage of the Inflation Reduction Act of 2022,tax credits are now available for standalone energy storage systems, and thus lenders may be willing to provide bridge capital that is underwritten based on the receipt of proceeds from an anticipated tax equity investment, similar to renewable energy projects.

Why do energy storage projects need project financing?

The rapid growth in the energy storage marketis similarly driving demand for project financing. The general principles of project finance that apply to the financing of solar and wind projects also apply to energy storage projects.

Why has the energy storage industry been held back?

The energy storage industry has been held back in developing many commercial market roles because of the inability for the governing bodies of these different markets to easily incorporate energy storage's flexibility into existing market rules.

What is the importance of valuing an energy storage project?

IMPORTANCE OF VALUATION There are two key aspects of valuing an energy storage project; the methodology used, and the value arrived at. Both components are important, but the complexity of the methodology is many times overlooked (both unintentionally and intentionally).

Can you finance a solar energy storage project?

Since the majority of solar projects currently under construction include a storage system, lenders in the project finance markets are willing to financethe construction and cashflows of an energy storage project. However, there are certain additional considerations in structuring a project finance transaction for an energy storage project.

What is the energy storage Finance Summit?

The Summit was the first Energy Storage Finance Advisory Committee Meetingfor a U.S. Department of Energy sponsored study to issues and challenges surrounding project and portfolio valuation.

Moreover, the capital available with this class of investors is limited compared to this solution's growth potential.
