

How can a battery energy storage system improve safety?

Clearly understanding and communicating safety roles and responsibilities are essential to improving safety. Assessing the safety risks of a battery energy storage system depends on its chemical makeup and container. It also relies on testing each level of integration, from the cell to the entire system.

What's new in energy storage safety?

Since the publication of the first Energy Storage Safety Strategic Plan in 2014, there have been introductions of new technologies, new use cases, and new codes, standards, regulations, and testing methods. Additionally, failures in deployed energy storage systems (ESS) have led to new emergency response best practices.

How can advanced energy storage systems be safe?

The safe operation of advanced energy storage systems requires the coordinated efforts of all those involved in the lifecycle of a system, from equipment designers, to OEM manufacturers, to system designers, installers, operators, maintenance crews, and finally those decommissioning systems, and, first responders.

Are new battery technologies a risk to energy storage systems?

While modern battery technologies, including lithium ion (Li-ion), increase the technical and economic viability of grid energy storage, they also present new or unknown risks to managing the safety of energy storage systems (ESS). This article focuses on the particular challenges presented by newer battery technologies.

Can a large-scale solar battery energy storage system improve accident prevention and mitigation?

This work describes an improved risk assessment approach for analyzing safety designs in the battery energy storage system incorporated in large-scale solar to improve accident prevention and mitigation, via incorporating probabilistic event tree and systems theoretic analysis. The causal factors and mitigation measures are presented.

Can energy storage systems be scaled up?

The energy storage system can be scaled up by adding more flywheels. Flywheels are not generally attractive for large-scale grid support services that require many kWh or MWh of energy storage because of the cost, safety, and space requirements. The most prominent safety issue in flywheels is failure of the rotor while it is rotating.

Many people see affordable storage as the missing link between intermittent renewable power, such as solar and wind, and 24/7 reliability. Utilities are intrigued by the potential for storage to meet other needs such as

relieving congestion and smoothing out the variations in power that occur independent of renewable-energy generation.

The year 2023 has been a significant one for lessons learned within the energy storage industry, particularly underscoring that battery safety demands heightened scrutiny. The occurrence of multiple incidents throughout the year has unequivocally demonstrated that maintaining the safety of batteries is an intricate and non-trivial task.

First established in 2020 and founded on EPRI's mission of advancing safe, reliable, affordable, and clean energy for society, the Energy Storage Roadmap envisioned a desired future for energy storage applications and industry practices in 2025 and identified the challenges in realizing that vision.

EPRI's battery energy storage system database has tracked over 50 utility-scale battery failures, most of which occurred in the last four years. One fire resulted in life-threatening injuries to first responders. These incidents represent a 1 to 2 percent failure rate across the 12.5 GWh of lithium-ion battery energy storage worldwide.
