## Energy storage subsidies are not in place

What are the different types of energy storage policy?

Approximately 16 states have adopted some form of energy storage policy, which broadly fall into the following categories: procurement targets, regulatory adaption, demonstration programs, financial incentives, and consumer protections. Below we give an overview of each of these energy storage policy categories.

Should the government focus on alternative electrochemical storage technologies?

The report recommends that the government focus R&D efforts on other storage technologies, which will require further development to be available by 2050 or sooner -- among them, projects to advance alternative electrochemical storage technologies that rely on earth-abundant materials.

How are battery energy storage resources developing?

For the most part, battery energy storage resources have been developing in states that have adopted some form of incentive for development, including through utility procurements, the adoption of favorable regulations, or the engagement of demonstration projects.

#### What is a storage policy?

All of the states with a storage policy in place have a renewable portfolio standard or a nonbinding renewable energy goal. Regulatory changes can broaden competitive access to storage such as by updating resource planning requirements or permitting storage through rate proceedings.

Can a power plant be converted to energy storage?

The report advocates for federal requirements for demonstration projects that share information with other U.S. entities. The report says many existing power plants that are being shut down can be converted to useful energy storage facilities by replacing their fossil fuel boilers with thermal storage and new steam generators.

What is the future of energy storage?

"The Future of Energy Storage," a new multidisciplinary report from the MIT Energy Initiative (MITEI), urges government investment in sophisticated analytical tools for planning, operation, and regulation of electricity systems in order to deploy and use storage efficiently.

While there is a big green energy industry controversy hanging over California at present, with the future of net metering (NEM) for rooftop solar in doubt, the support for energy storage has been welcomed by the Long Duration Energy Storage Association of California trade group.
