Industrial parks are areas of land developed as a site for factories and other industrial businesses. There are currently three major industrial estates in Guyana located at Houston, Ruimveldt and Eccles. But these industrial zones are in close proximity to residential areas and it poses a lot of challenges, primarily that of traffic.
