Don't become victim to a Solar Panel company's deceptive practices. Take the following steps. Demand a copy of all documents and read the terms of the deal in paper form before committing to anything.; Be cautious about providing your signature or initials on an iPad, tablet or other document.; Do not allow access to your credit report unless you understand the risks and are ...

Many times, the solar panel company may not want to sell you the panels. If you, the buyer, purchases the panels, you would receive the tax credit, not the solar company. If the solar company leases you panels and only promises to sell you the solar power, the solar sales company may receive the tax credit, not you, the homeowner.
