

# Italian energy storage

How much energy storage is installed in Italy?

As of 30 June, 2023, a total of 3,045 MW and 4,893 MWh of energy storage is installed in Italy according to ANIE Rinnovabili, the national trade body representing the renewable and clean energy sectors. The energy storage market in Italy doubled in capacity in the first half of the year, though Q2 saw the first slowdown in nine quarters.

Does Italy need 9 GW/71 GWh of energy storage?

What is the EU state aid scheme for energy storage in Italy?

The European Union (EU) Commission has approved a state aid scheme aiming to fund the rollout of over 9 GW/71 GWh of energy storage in Italy. The scheme totalling EUR 17.7 billion (US\$ 19.5 billion) will provide annual payments covering investment and operating costs for those developing, building and operating large-scale energy storage in Italy.

How will Italy invest in electricity storage?

Italy will promote investments in utility scale electricity storage to reach at least 70 GWh, and worth over Euro 17 bn, in the next ten years. The new storage capacity will be acquired through tenders published by Terna, the manager of Italy's high voltage grid. The next tender will be released in 2024.

How will Italy develop utility-scale electricity storage facilities?

To develop utility-scale electricity storage facilities, the Italian Government set up a scheme that was approved by the European Commission at the end of 2023. Italy will promote investments in utility scale electricity storage to reach at least 70 GWh, and worth over Euro 17 bn, in the next ten years.

The European Commission has approved a EUR 17.7 billion (\$19.5 billion) Italian scheme to support the construction and operation of a centralised electricity storage system to integrate renewable energy sources

The Italian Regulatory Authority for Energy, Networks and Environment (ARERA) in resolution no. 574/2014/R/eel define "storage system" as a set of devices and equipment, whose function is to absorb and release electrical energy, and is designed to operate in the electricity grid in order to feed into or withdraw electricity from the grid.

The residential energy storage market in Italy is already very strong, with the second-highest (321MWh) deployments in 2022 after Germany according to figures from trade body SolarPower Europe. This is partially down to the country's Superbonus 110% tax credit for home renovations which increase energy efficiency, including residential energy ...

Transmission System Operator ("TSO") and approved by the Italian Energy Regulator. The list of eligible electricity storage technologies will be revised every two years to reflect technological developments. Currently, eligible technologies include electrochemical lithium-ion storage, as well as hydro pumped storage plants.

Battery energy storage system (BESS) capacity in Italy reached 587MW/1,227MWh in the first three months of 2022, of which 977MWh is distributed energy storage, according to the national renewables association, ANIE Rinnovabili. Like Germany, Italy's BESS market is currently dominated by the residential and commercial & industrial segments.
