Is Greece preparing for a new energy storage policy?

Greece's energy storage sector is heating up, with the government confirming plans to publish an energy storage policy frameworkand hold tenders for 700 MW of battery storage.

Will Greece co-manage a EUR5 billion RRF?

To date, Greece is the only EU member state to sign an agreement with the European Investment Bankto co-manage up to EUR5 billion of Greece's RRF. "The energy ministry has allocated EUR450 million from Greece's RRF to support specific storage projects, and this is going to be announced shortly," Sdoukou said.

Who is eligible to participate in the first energy storage auction?

To be eligible to participate in the first auction, projects must hold a valid Energy Storage Licencewhile a set of other eligibility criteria (including soundness of the technology used and minimum power injection capacity) must be met.

Athens Renewable Energy is a proposed project combining 250 megawatts of solar with a 250-MWh lithium-ion battery energy storage system (BESS). This project will be located in Placer County, California, north of the Greater Sacramento area. The facility will be sited on approximately 3,000 acres of privately owned land.
