Do I need a label for lithium ion batteries?

If you're shipping lithium ion batteries contained in or packed with equipment, use a battery label with UN3481. Lithium metal batteries will use labels with one of the following UN numbers: If you're shipping lithium metal batteries as a standalone (no other items in the package), use a battery label with UN3090.

Did the postal service change the shipping standards for lithium batteries?

The Postal Service announced these revisions via a Federal Register notice titled "Revision to Mailing Standards for Lithium Batteries," which was published on July 26, 2017 (82 FR 34712-34715).

What is a lithium battery label?

Labels are printed with the letters 'UN' and a 4-digit number. Think of it like a special code. These numbers clarify 2 types of crucial information: the lithium battery type and packaging method. Packaging method refers to how the lithium batteries are being shipped. This can be done in 3 ways:

Does USPS accept lithium batteries?

The USPS has revised its hazardous materials shipping regulations, restrictions and guidance--Publication 52, better known simply as Pub 52--to further restrict how the service accepts and transports lithium battery devices. (Standalone batteries are not subject to these new rules.) There are two important new restrictions:

Can a lithium battery be attached to a mailpiece?

Except for mailpieces containing button cell batteries properly installed in the equipment they are intended to operate, mailpieces containing mailable lithium metal or lithium-ion batteries must be rigid, sealed, and of adequate size, so the lithium battery mark can be affixed to the address side without the mark being folded.

Do you need a DOT certification to ship lithium batteries?

When shipping lithium batteries, businesses must comply with U.S. Department of Transportation (DOT) standards and Pipeline and Hazardous Materials Safety Administration (PHMSA) standards for preparing shipments that contain lithium batteries.

Lithium Batteries can be used to power most household and personal devices, including mobile phones, watches, and laptops. However without suitable handling, they can present as a fire and/or explosion hazard; Our range of UN Lithium Battery Postage labels are fully compliant with ADR, RID, IMDG & IATA requirements.

October 1, 2021 Update - PHMSA has released a revised (September 2021) Lithium Battery Guide for Shippers, to assist shippers to safely package lithium cells and batteries for transport by all modes according to the latest (May 11, 2020; HM-215O) regulatory requirements.

To comply with Section II IATA shipping requirements, shipments containing lithium batteries and cells must comply with specific packaging guidelines. Ensure that lithium batteries are individually packaged in fully enclosed inner ...

Recalled, damaged or non-conforming cells or batteries are also prohibited from being sent by Australia Post. How to package lithium batteries. Make sure that the electronic device you're sending can't be turned on accidentally, and you have used strong internal and external packaging. Under no circumstances should lithium batteries be packed ...

o Revision to the lithium battery mark. A telephone number is no longer required on the lithium battery mark. Lithium Battery Label: Under the latest, 60th edition of the IATA regulations, effective from 1st January 2019, the new labels will be mandatory. Changes to the Lithium Battery Mark for 2024 The introduction of the telephone number requirement for lithium battery labels initially left many shippers and carriers puzzled.

Packages being sent domestically containing new electronic devices, in original unopened packaging or manufacturer certified new or refurbished devices do not require you to select hazmat when printing your label on eBay. Place the lithium battery label for shipping on the surface of the package (side visible) without folding it or overlapping it with other labels. Add an emergency contact number. Use a lithium battery label for shipping that is durable, water-resistant, and smudge-resistant. The labels should be printed clearly and according to recommended colors.

An ID8000 label must be applied ... This requirement is to ensure that proper training has taken place and that all applicable safety regulations are properly followed for such shipments.
