What is the future of energy storage?

Renewable penetration and state policies supporting energy storage growth Grid-scale storage continues to dominate the US market, with ERCOT and CAISO making up nearly half of all grid-scale installations over the next five years.

What will energy storage be like in 2024?

In 2024,the global energy storage is set to add more than 100 gigawatt-hoursof capacity for the first time. The uptick will be largely driven by the growth in China, which will once again be the largest energy storage market globally.

How many new energy storage projects are commissioned in China?

Figure 2: Cumulative installed capacity of new energy storage projects commissioned in China (as of the end of June 2023) In the first half of 2023, China's new energy storage continued to develop at a high speed, with 850 projects (including planning, under construction and commissioned projects), more than twice that of the same period last year.

Is it profitable to provide energy-storage solutions to commercial customers?

The company is working on a large-scale 220 MW Battery Energy Storage System project in North Rhine-Westphalia and is likely to be commissioned in 2024. The battery energy storage systems industry has witnessed a higher inflow of investments in the last few years and is expected to continue this trend in the



future.

The cumulative installation of cold and heat storage was about 930.7MW, a year-on-year increase of 69.6%, accounting for 1.1% of the total installed energy storage capacity. China's new energy storage capacity will be installed in 2023. In 2023, China's new installed capacity of energy storage was about 26.6GW.

The cost reduction in the new energy storage process has surpassed industry expectations, along with the rapid pace of development. In March 2022, the National Development and Reform Commission and the National Energy Board introduced the implementation program for new energy storage development under the 14th Five-Year Plan.

Microvast Energy recently announced the securing of a large contract to supply a utility-scale battery energy storage system to a US customer. The energy storage portion of the project is 1.2GWh and will be co-located with a solar plant. The energy storage containers will begin shipping in 2023, with commercial operation expected in 2024.

The case for long-duration energy storage remains unclear despite a flurry of new project announcements across the US and China. Global energy storage's record additions in 2023 will be followed by a 27% compound annual growth rate to 2030, with annual additions reaching 110GW/372GWh, or 2.6 times expected 2023 gigawatt installations.

China has also accelerated to promote the rapid development of new energy storage industry for the construction of a new energy system and carbon peak carbon neutral goals. 2023, the new domestic installed capacity of new energy storage of is about 22.6GW, and the average length of time of energy storage is about 2.1 hours.
