Will Sao Tome & Principe get a 2 MW solar project?

The island nation of Sao Tome and Principe switched on the initial phase of its first 2 MW solar project in August. Construction of 1.4 MW of PV capacity is now underway at two airports, and developers plan to install a total of 1.7 MW by 2023.

The project aims to strengthen the nation's capacity in renewable energy and energy efficiency through an extensive and targeted training programme. This comprehensive initiative will address existing knowledge gaps and equip key players with the necessary skills to effectively manage and promote renewable energy and energy efficiency.
