Can lithium batteries be shipped domestically?

Lithium batteries can be shipped domestically within the US, including to Alaska and Hawaii. Different requirements apply to domestically-shipped rechargeable lithium batteries than on international commercial air transportation.

Can I ship a lithium battery cross-border?

There are regulations attached to the cross-border shipping of batteries to ensure they travel safely. These regulations vary depending on the type of batteries. Lithium batteries, for example, are classified as Dangerous Goods, so not all types of lithium batteries are accepted by DHL Express which you can check [here](#).

Where can I mail lithium batteries?

Customers can mail packages containing lithium batteries installed in electronic devices to their local Post Office for many international destinations, and Army (APO), Fleet (FPO), and Diplomatic Post Office (DPO) locations. For the current regulations regarding the mailability of lithium batteries, please visit your local Post Office.

Can I ship a large battery?

Battery size. Large batteries can hold more charge and generate bigger explosion if something goes wrong. Hence, shipping large batteries require documentation and licenses. Most consumer-level electronics usually use small batteries to keep these devices compact and portable, so there should be no issues with regards to shipping them.

Are lithium batteries dangerous?

Many modern electronic devices require lithium batteries to operate such as laptops, tablets, and smartphones. However, restrictions have been set in the shipping of certain lithium batteries because they pose risks of exploding or catching fire and are thus considered dangerous goods.

Can I ship electronic devices with batteries?

Consult your shipping carrier for any specific regulations when shipping electronic devices with batteries. Restrictions may vary by state as well as internationally, and from carrier to carrier, so it's best to confirm before shipping. Electronics can be damaged easily so make sure to pack them well.

The Future of Lithium Battery Shipping. As lithium battery use continues to grow, shipping regulations will likely evolve as well. The IATA updates its lithium battery shipping guidelines annually, with the latest version effective from January 1st, 2021.^9. Potential future developments include: Stricter packaging and labeling requirements

- o Revision to the lithium battery mark. A telephone number is no longer required on the lithium battery mark. Lithium battery marks with a phone number may continue to be applied until December 31, 2026.
- o Packing Instructions 965 and 968 - removal of Section II
- o Packing Instructions 966 and 969 - clarification on protection against ...

Lithium metal batteries will use labels with one of the following UN numbers: UN3090 UN3091; If you're shipping lithium metal batteries as a standalone (no other items in the package), use a battery label with UN3090. If you're shipping lithium metal batteries contained in or packed with equipment, use a battery label with UN3091.

Any package bearing a lithium battery shipping label should also be marked as dangerous goods and have the necessary documentation; It may be necessary to use specialized packaging to ensure the safety; Lithium Metal Batteries These are batteries that use lithium as an anode. They have a long life and can produce anywhere between 1.5V-3.7V.

Background In order to comply with Department of Transportation (DOT) regulations, Lithium Ion batteries used in Canon Camera products (EOS DSLR, video camcorders, PowerShot digital compact cameras, etc.) could be classified as hazardous material and would require a specific shipping method be followed per regulations.
