Who is Sol Kerzner?

Sol Kerzner elevated South Africa's hotel industry, founding Southern Sun Hotel Group, Sun International, the Atlantis hotels and brand One&Only, over a hotel career spanning the best part of six decades.

Where is Sol Kerzner buried?

Sol Kerzner will be buried at a small, private funeral with only immediate family in attendance. Solomon (Sol) Kerzner, one of the world's most innovative hoteliers, founder of the Southern Sun hotel group, Sun International and Kerzner International, has died of cancer at the Kerzner family home, Leeukoppie Estate, in Cape Town, South Africa.

Why did Sol Kerzner build a hotel?

From his earliest hotels, Sol Kerzner was guided by a single driving imperative: to 'Blow away the customer'. When scouting for locations around Durban, or later in Mauritius or The Bahamas, if Sol was not 'blown away' by the location, he would move on and find another stretch of beach to build the hotel and resort.

Why did Sol leave Kerzner International?

Sol, who was by then Executive Chairman of Kerzner International, decided to return to the role of CEO, to continue the work of the company and to complete what he and Butch had been working on.

Did Sol Kerzner see Sun City?

The balcony of the King's Suite at The Palace is the best vantage point to catch a glimpse of the vision that Sol Kerzner had when he flew over the Pilanesberg and saw the stretch of dormant volcanic land that would later become Sun City. At the time of that fortuitous helicopter trip in 1978, Kerzner was slowly making moves in the hotel industry.

Where did Sol Kerzner live?
