The project is being developed by Ameren, Cass County Solar and Savion. The project is currently owned by Ameren with a stake of 100%. Cass County Solar Project is a ground-mounted solar project which is planned over 1,700 acres. The project is expected to supply enough clean energy to power 22,000 households.

Cass County Solar will be the first solar project of its kind in Nebraska. Subject to local and state approvals, the project is scheduled to begin operations as early as December 2025.
