What solar incentives are available in Washington?

Washington residents have several solar incentives to save thousands when purchasing residential solar panels. The residential clean energy credit, a federal solar tax credit program previously known as the investment tax credit, is one of the most important solar incentives available for American homeowners.

How do I apply for a Tacoma Power incentive?

You must be a current Tacoma Power residential customer. You must purchase and install your equipment prior to applying for the incentive. Hardwired and plug-in equipment qualifies for the incentive. You must provide proof of purchase (dated within the last 90 days) with your application for one of the approved products. Must be UL Listed.

Are solar panels tax deductible in Washington State?

Benefits for installing solar panels include sales tax exemptionfrom Washington State for qualifying solar equipment (ESS Senate Bill 5116). From July 2019 and through December 2029, equipment for solar energy systems smaller than 100 kilowatts is exempt from state and local sales and use taxes.

Can you get a tax credit for solar?

At the federal level, consumers can receive a 30 percentfederal tax credit for solar installations and this now includes stand-alone energy storage devices that have a capacity rating of 5 kilowatt hours or greater.

The Home Energy and Appliance Rebate (HEAR) Program is a partnership between the City of Tacoma and Tacoma Power that helps low--and moderate-income households upgrade to high-efficiency electric heat pumps for space heating and water heating.

The 240-volt outlet incentive can be paired with either the hardwired Level 2 charger or Smart Splitter to help cover installation costs. Installed by a licensed electrician. Electrical panel has space to add a new 240 volt service. New EV circuit must be a minimum of 30 amps. One 240-volt outlet incentive per Tacoma Power customer account.

Next Steps for Installing Solar in Tacoma. Solar energy use nationwide has gone up significantly in the last 15 years, in part due to the growth in the number of solar incentives. You may get these incentives from the federal government, the Washington government or your local utility company.

The Net Meter also measures electricity purchased from Tacoma Power in kWh. That is shown on the first channel of the Net Meter (the first number to appear after the display shows 888888). To determine your bill, the amount of electricity sent to Tacoma Power is subtracted (or credited) from the amount of electricity purchased from Tacoma Power.

Your application and project must be pre-approved by Tacoma Power.

How much will Tacoma Power pay or credit my utility bill for excess solar power? For a set of roof top solar panels less than 100 kW, Tacoma Power will credit your TPU account at our retail power rate, which is set by the Tacoma Municipal Code TMB 12.06.215. Contact our solar experts by emailing BizRebates@cityoftacoma or calling 253-502-8363.

Currently, Tacoma Power has not reached the tax credit cap; however, additional customer interest in solar could cause the cap to be reached at a later date. Without modification to the State law, incentive payments to all Tacoma Power solar customers could be reduced for the duration of the Project.

Utilities offers net metering credits. ... The biggest financial incentive for solar homeowners is the 30% federal solar tax credit. The tax credit equals 30% of the solar installation costs and directly reduces your federal income tax liability.

The Tacoma Power Customer Service Policies and Tacoma Municipal Code 12.06.A include requirements for supplying electrical service. Tacoma Power Transmission and Distribution Electrical Construction Standards and the Electric Service Handbook provide more detail about the requirements for specific portions of the service system we supply.

The average price per watt of solar power in Tacoma, WA is \$2.65/W. These prices are before incentives. After the federal solar tax credit, the final cost will drop by 30%, down to \$22,483 for a 12.11 kW system. Many states even offer local rebates and incentives that lower the price further--sometimes by thousands of dollars.
